### ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Shankar Singh Memorial Trust, Gulbarga, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Aryan B.Ed College, No.147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga-585105, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2004-05 with an annual intake of 100 students.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - The institution has acquired the land for setting up the teacher education institution.
  - The institution has made arrangements for conducting the course in the rented premises.
  - c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
  - d. The institution has selected the <u>Principal and Seven</u> lecturers for the said course and the list of faculty members has been approved by the affiliating University.

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Aryan B.Ed College, No.147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga-585105, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following.

The institution will ensure that <u>Principal and Seven</u> faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions
  of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the
  Regional Committee may withdraw the recognition under the Provisions of
  Section 17(1) of the NCTE Act, 1993.

# ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution Aryan B.Ed College, No.147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga-585105, Karnataka has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.
- 3. AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- 4. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall submit revalidated FDRs of the enhanced values, in joint account 1 with the SRC before 30 June. 2015 failing which the recognition will be withdrawn.
  - The institution shall create additional facilities that include (a) additional built-up area, II. (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - The applicant-institution for additional unit will be required to submit the required III. documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - The Regional Committees shall arrange for verification of documents, inspection of IV. these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Aryan B.Ed College, No.147, Vidyanagar Colony, Opp. Basaveshwara Hospital, Sedam Road, Gulbarga-585105, Karnataka for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at !! & III herein before 31.10.2015.
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as Cont .... 2 applicable.

d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

Available infrastructural facilities:

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last

j) The institution shall be free to post additional relevant information. if it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
