

## 20 AMENDMENT CLAUSE:

No amendments to the Trust Deed/Byelaws/Rules shalk hade which may prove to be repugnant to the Provisions of Section 2(15), 11, 12 & 13 and 80 6 of the Income tax Act, 1961 as amended from time to time. Further, no amendment shall be made without the prior approval of the Commissioner of Income tax.

## 21. INVESTMENT CLAUSE:

The funds shall be invested in the modes specified under the Provisions of Section 13(1)(d) r.w. section 11(5) as amended from time to time.

The funds and the income of the Trust shall be solely utilised for the achievement of its objects and no portion of its shall be utilised for payment to the Trustees by way of Profit, Interest, Dividends, etc., However, for carrying out the Objects of the Trust effectively, any reasonable remuneration as may be decided by the Board of Trustees may be fixed and paid to any/all the Trustees.

## 22. DISSOLUTION CLAUSE:

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/Government Body, but, the same shall be transferred to another Charitable Trust whose objects are similar to those of this Trust and which enjoys recognition under section 80 6 of the Income tax Act, 1961 as amended from time to time.


